Science Program Evaluation

Grades K-5 — Ms. Christine Tona, Executive Director for Curriculum

Grades 6-8 — Mr. Harry Theo

Grades 9-12 — Mr. Kenneth Konopa

The panel presented the science program evaluations which are done every four years. Ms. Tona explained that at the K-5 level science is not in the curriculum's forefront. She said that ways are being looked at to integrate more science and technology into the curriculum. Mr. Theo said that at the junior high school level the program begins to implement a more hand on approach for the students. The program becomes more engaging and real life situations such as hurricanes, Ebola and local viruses are explored in the classes. He said that students are earning awards in the science program, the science Olympiads earned 6th place and medaled in nine events. He said that the program may need to provide a new text book. In response to Board President Campasano's question about the rating in the evaluation about the program not addressing the needs of the highly competent students, Mr. Theo said that the low rating is due to no longer having a 7th

grade honors program. Mr. Konopa said that he is proud to represent the hardworking, dedicated and inventive high school science department staff. He also thanked the staff in grades K-8 for their hard working in preparing the students for the high school science curriculum. Mr. Konopa said that this year has been the best ever for the Science Olympiads with students being called 25 times to receive awards; putting West Babylon with Ward Melville students. Mr. Konopa said that next year the district is adding an introductory science program for students who may have a language barrier. Board President Lucy Campasano said that the Board recently had the opportunity to view the work of the Science Olympiad students and they were extremely impressed with their intelligence and their work.

Ms. Tona congratulated retiring Social Studies teacher Janine Augustine and Security Guard Al Frank, who are on this evening's agenda. The Board thanked them for their service and wished them well in their retirement. Board President Lucy Campasano wished them well and said she will always think of Mrs. Augustine fondly as Miss Dupuis.
