Information, Procedural: B. Statement of the Board and/or Superintendent

Dr. Farrelly welcomed and thanked everyone for joining the meeting. She commenced by furthering the discussion of transportation needs within the district and other districts. The district is currently on a day by day scheduling system regarding athletics. The Athletics Department is working with other districts to shift the game times so that students can be transported. Dr. Farrelly drew the Board's attention to the Emergency Resolution for Transportation that was on the agenda. The resolution allows the district to enter into contracts with available transportation companies on a temporary basis to cover transportation needs. Mrs. Gillis and Dr. Farrelly met and spoke with transportation companies, and informed the Board that a number of private school transportation routes and other special needs routes that did not have coverage - will now be covered by outside companies - starting this Thursday. She pointed out that our Transportation Department is addressing each concern/question and making adjustments one at a time. Also, all concerns of transportation safety matters are taken seriously and addressed by the administration team. She also expressed and understands how frustrating it has been and thanks the community for the patience and understanding. In addition, she thanked the Transportation Department for addressing all the concerns to the best of their ability.

Dr. Farrelly concluded by expressing her gratitude to the Buildings and Grounds and ITS Department for getting us ready for opening day. In a few weeks, the teams worked together to address many facilities needs and work with outside groups to coordinate the rebuilding, restoration and reconnection of countless IT systems.

Today's Board presentations include Mr. VandeWater from McHugh who will provide an overview of JHS Eagle Hall seat options for the board, Karalisa Grundner from BBS who will provide an overview of South Bay parking lot proposal and Mr. Payne who will provide an update on our DCIP plan.

WHEREAS, due to the aforesaid situation the West Babylon Union Free School District is unable to provide all of the required transportation services necessary to adequately transport the students as mandated by Law, therefore,

IT IS RESOLVED, that pursuant to General Municipal Law §103-4, and NYS Education Commissioner's Regulation 156.12(f) the West Babylon Union Free School District hereby declares a school district transportation public emergency arising out of an unforeseen condition which requires immediate action which cannot wait to complete statutory competitive bidding or the letting of competitive transportation contracts,

IT IS FURTHER RESOLVED that the Assistant Superintendent for Finance and Operations be permitted to seek to let contracts and let contracts for the transportation of school children for all school districts transportation purposes and needs, and authorizes the President and Superintendent, without further action due to said immediate emergency to sign such contracts.
